## TERMS AND CONDITIONS

**PAYMENTS:** All application forms must be accompanied by a nonrefundable deposit of \$500.00 per person or full payment is required after December 1, 2011. Checks for the entire package should be made payable to Benny Hinn Ministries Travel & Tours. The following cards are accepted Visa, American Express, MasterCard and Discover. Full payment is due December 1, 2011.

**\*FEES:** Taxes, gratuities, and fuel surcharge are included in the base price. Fees are subject to change at any time.

**\*\*CASH/CHECK DISCOUNT:** The cost of the tour is \$3,745.00 (AIR/LAND) and \$2,045.00 (LAND ONLY); however you can save \$50.00 by paying by cash/money order or check.

**LAND ARRANGEMENTS:** All sightseeing, as per itinerary, is aboard private motor coach with services of professional English speaking guide. Entrance fees to all sites, as per itinerary, are included. Please note: All the large cities have made an effort to accommodate those with disabilities over the past few years by installing ramps where possible in museums and church entrances. However, there are still many restricted sites that cannot be reached with wheelchairs.

**SINGLE TRAVELERS:** Price per person is based on two persons sharing twin-bed rooms with private facilities in hotels and throughout the tour. Single rooms are limited but may be requested at time of booking for an additional charge (\$550.00 for Israel and \$299.00 for Eilat). While single rooms provide privacy they are often smaller than twin rooms and are sometimes located away from the group in different areas of the hotel, and may be in high traffic areas such as near stairways/elevators. We do not like to assess an additional charge for a single traveler and will make every effort (if you so desire) to match you with a same-gender roommate when we receive your application, but we do not guarantee a roommate be matched. If a single room must be assigned due to your roommate's cancellation, incompatibility, or for any other reason (even at the last moment or while on tour), we must charge you the tour's single supplement or prorated amount. One partner in double occupancy wishing to move to a single occupancy room at any time during the program will be responsible for paying both single supplements.

**LAND ONLY PASSENGERS:** Land Only participants are ultimately responsible for their own flights and transfers to and from airports and hotels. Land Only passengers need to arrive in Israel on Dec. 23rd with hotel check-in is after 4pm and depart the evening of Dec. 29. BHM Travel & Tours will assist passengers in arranging for transfers and extended stays if participant request and advises BHM Travel & Tours of their flight itineraries and plans a week in advance.

**OPTIONAL EXTENSION:** Extend your trip to Eilat and attend the special New Year's Eve Communion Service and celebration with Pastor Benny on the Sea of Galilee. Enjoy two relaxing days in a resort hotel in Eilat. Relax on the beautiful beaches and sail with us in a boat on the Red Sea. Extension includes round trip airfare Tel Aviv to Eilat, three hotel nights, the New Year's Eve Communion Service and a special celebration dinner with Pastor Benny. The additional Extension cost is \$1,000.00 per person based on double occupancy. Single supplement is \$299.00 additional.

**LATE PAYMENTS:** A late fee may apply for bookings received after December 1, 2011. Reservations are subject to deadlines with airlines and various vendors. Special delivery charges incurred will also be due in advance.

**TRANSFERS:** Transfers are seat-in-coach basis unless otherwise specified. Passengers arriving and departing independently are responsible for their own transfers.

**NOT INCLUDED:** Meals not specified in itinerary, optional tours, charges for passports, visas, vaccinations and inoculations, laundry, liquor, excess baggage charges, telephone or cable charges, private non-group transfer, items of a personal nature, and any items not specifically listed as included.

**INSURANCE:** Travelers Insurance is included in tour package. For your peace of mind and protection a traveler's insurance policy through Mediguard Travel Insurance, offering coverage for lost baggage, medical emergency while in Israel only. Please see policy for details of coverage at [www.mediguardtravel.com](http://www.mediguardtravel.com) or call 1-718-258-5200 and refer to plan "Benny Hinn Ministries December Group".

**VISA & HEALTH:** A valid passport is required for all participants. There is no visa requirement for citizens of the USA for travel to Israel. Other nationals should contact the appropriate consulate for regulations. Gil Travel will not process visa

applications. No inoculations are required at press time for travel to Israel, but please check with local public health authorities for up to date information.

**BAGGAGE:** Although certain airlines allow two pieces of luggage, due to limited bus space, only one carry-on bag (not to exceed 45 inches) and one checked bag per person (not to exceed 50 lbs). Benny Hinn Ministries Travel & Tours is not responsible for lost or damaged baggage. Please check with your airlines carrier luggage restrictions as excess baggage charges may apply.

### **CANCELLATION:**

1. All cancellations must be received in writing.
2. Cancellations received prior to December 1, 2011 forfeit \$500.00 per person.
3. Cancellations received on/after December 2, 2011 to departure forfeit 100% of package price per person, including taxes, supplements, deviation fee, and any other costs incurred (if applicable). Special cases may qualify for refunds on the full tour package. Please contact the travel insurance provider if your reason for cancellation qualifies under their protections plan.
4. Tour participation is nontransferable. Names cannot be transferred on reservations or airline tickets.

**RESPONSIBILITY:** Benny Hinn Ministries Travel & Tours is acting solely as an intermediary agent for the travel suppliers providing means of transportation, hotel and/or all other related travel services being purchased (the "Third Party Providers"). Benny Hinn Ministries Travel & Tours therefore, shall not be liable or responsible for (i) any injury, illness, loss or damage to any person or property or additional expense involved with travel resulting from acts of God, detention, annoyance, delays, quarantine, strikes, thefts, pilferage, force majeure, diseases, mechanical difficulties, failure of any means of transportation to arrive or depart as scheduled, civil disturbances, terrorism, government restrictions or regulations, and discrepancies or changes in transportation or hotel services or any other matter or event over which Benny Hinn Ministries Travel & Tours has no control; or (ii) for any state of quality, hygiene, political instability, cuisine, sanitation facilities, cleanliness, telecommunications facilities, methods of conducting business, emergency medical evacuation, treatment or medical services existing at any travel destination. By embarking upon his/her travel, the passenger voluntarily assumes all risks involved with such travel, whether expected or unexpected. The issuance and acceptance of any exchange orders or tickets shall constitute consent by the purchaser and/or passenger to the foregoing conditions. All exchange orders and tickets are also subject to such additional terms and conditions as the third-party providers may impose. Finally, Benny Hinn Ministries Travel & Tours shall not be liable for any funds received from the purchaser and/or passenger and paid over to any third-party provider which subsequently becomes insolvent or files any bankruptcy or similar proceedings or fails to deliver services.

**SPECIAL NOTE:** Delays, cancellations and overbooking by participating third-party providers may occur on air flights, cruises and land reservations. While Benny Hinn Ministries Travel & Tours will do its utmost to avoid these inconveniences, it shall not be liable or responsible for the acts or omissions of such Third Party Providers.

Benny Hinn Ministries Travel & Tours reserves the right (i) to cancel any tour, substitute hotels and make such alterations in tour itineraries as may be necessary or desirable for the convenience of the parties and the proper carrying out of the tour(s); and (ii) to decline to accept or retain any person as a member of any tour. All additional cost, if necessary, shall be the passenger's responsibility. In addition, Benny Hinn Ministries Travel & Tours may cancel any tour prior to departure. In such a case, a full refund of all payments will constitute full settlement with the passenger and/or purchaser of the tour.

All disputes arising under, in connection with, or incident to this agreement shall be litigated, if at all, in and before a court located in the City of Philadelphia, Pennsylvania, USA, and in the courts of no other city, state or country.

Retention of tickets, reservations or bookings by the purchaser and/or passenger after issuance shall constitute consent to the above terms, as well as an agreement on his/her part to convey the contents hereto to his/her travel companions or group members.
